- **Fire Protection Plan Review - \$200**
 - Includes initial plan review
 - Includes (1) revision review
 - \$50 fee for every additional re-review required

- **Fire Alarm and Detection Systems Review - \$100**
 - Includes initial review
 - Includes (1) revision review
 - \$50 fee for every additional re-review required

- **Fire Alarm Acceptance Test**
 - Included in Fire Alarm & Detection Systems Review Fee
 - Additional Tests - \$70 + \$35/hr after first hour

- **Sprinkler Suppression Systems Review - \$150 + .50 for every head exceeding 100 heads**
 - Includes initial review
 - Includes 1 inspection/hydrostatic test
 - 50% of original fee for every additional re-review required

- **Sprinkler Installation & Hydrostatic Test Fee**
 - Included in Sprinkler Suppression Systems Review
 - Additional Tests – 50% of original Sprinkler Suppression Systems Plan Review fee

- **Kitchen Cooking Suppression System - \$75**
 - Includes initial Kitchen Cooking Suppression System review
 - Includes (1) acceptance Test
 - \$50 fee for every additional re-review required

- **Kitchen Cooking Suppression System Acceptance Test**
 - Included in initial Kitchen Cooking Suppression System review
 - Additional Tests - \$50

- **3rd Party Review Fee – Pass on of 3rd Party's fee + 15%**
